

- Judge, Kerala High Court: Appointed on 26th September 1985
- ChiefJustice, Gujarat High Court: Appointed on 16th July 1998
- ChiefJustice, Madras High Court: Appointed on 9th September 1999
- Judge, Supreme Court of India: Appointed on 8th June 2000
- ChiefJustice of India: Appointed on 14th January 2007
- Chairman, National Human Rights Commission: Served from 7th June 2010 to 11th May 2015

Notable Judgments

- School Lunch Program: Made distribution of lunch compulsory in schools to support under privileged children
- Narcoanalysis: Passed a judgment prohibiting narcoanalysis in interrogations, citing concerns about human rights and the reliability of evidence obtained through such means
- Reservation: Upheld the Mandal Commission's office order providing 27% reservation for Other Backward Classes (OBCs) in educational institutions, promoting social justice and equality
- Human Rights: Initiated a suo motu complaint against human rights violations in Kasaragod due to pesticide spraying and recommended establishing a super-specialty hospital for victims.

Legacy

Justice K.G. Balakrishnan's legacy extends beyond his judgments. He has inspired a generation of lawyers and
judges with his commitment to justice, integrity, and human rights. His appointment as Chief Justice of India
marked a significant milestone in the history of the Indian judiciary, as he became the first Dalit judge to hold this
position.
